YM22.9 Minute of Record: Acknowledgement of Country

At the Opening Session Gedda Fortey (CRQ) introduced Ljudan Michaelis-Thorpe, a proud Bidjara/Dhunghutti woman from central west Queensland, writer/producer and documentary filmmaker.

Ljudan Michaelis-Thorpe welcomed Friends. She paid respect to the elders of her country and invited us to focus on our own area of Aboriginal country, remember the traditional elders, and tap into the energy from land, sky and sea. We can learn to 'read the skies again' as Indigenous people have done over the years. The disconnect between today's world and the knowledge of Aboriginal wisdom can be overcome by being open to Indigenous astronomy which offers resilience and adaptability.

Ljudan drew attention to the theme for the coming NAIDOC Week – "Get Up, Stand Up, and Show Up". This emphasises the willingness of Indigenous people to bring forward their wisdom on today's problems and help find solutions. In the 'fight' for climate justice we have to work together, and regenerative agriculture is a way of connecting with Country.

Ljudan said the elders of her country sent blessings to us all. In response, the Presiding Clerk thanked Ljudan for helping us attend to the rhythm of life and the imagery all around us, and wished all Indigenous Australians a wonderful NAIDOC Week.

C. Documents in Advance Reports with Part B Items which were resolved in Preparatory Sessions

Yearly Meeting notes the following items from Reports in *Documents in Advance 2022*, which were resolved through Regional Meetings and YM22 Preparatory Sessions (this list has been on the YM22 website for Friends to review). We note that acceptance of DiA reports with a Part B that were agreed to by all RMs or through a Preparatory Session is a new process for YM22. This new process was shared with Friends ahead of YM22. Part B items that were resolved at Preparatory Sessions were shared with RMs prior to YM22 with a request to consider any items of concern to their RM and to bring this to the attention of the AYM Secretary. None of these Part B items was brought to the Secretary for further consideration at a Formal Session of YM22.

We have heard a concern that this process does not allow for discernment at a gathering of Friends during YM, which may not allow for a shift in the leading of the Spirit at a full gathering of Australian Friends.

We ask that this process be reviewed by RMs before future YMs.

Climate Emergency & Species Extinction Working Group

Item 4: CESEWG proposes to hold a Preparatory Session in May 2022 to report on the Questionnaire they had circulated and to hear Friends' ideas as to future work of the WG. <u>Outcome</u>: This was done.

Item 5: Would RM's appreciate the WG holding a Zoom consultation with interested Friends as we prepare a plan for YM23? Outcome: This was supported.

Handbook Revision Committee

Section 4.5 Care of travellers: <u>Outcome</u>: Expanded section re Sojourners Section 5.2.7 AYM Archivist: <u>Outcome</u>: Expanded section to cover the current legislation re Archival material.

Publications Committee

Item 1: Would Young Friends be willing to look at the Young People's pamphlet? <u>Outcome</u>: No Young Friends attended the session.

Item 2: Would Friends forward suggestions for any pamphlets that need updating and/or subjects that could be considered for new pamphlets? <u>Outcome</u>: This was discussed and plans made.

Item 3: We invite feedback on the use of Creative Commons for AYM publications. <u>Outcome</u>: Discussion held on possible ways forward.

- use AYM where YM is used.
