Aletia Dundas the 2022 State of Society Address online on Saturday 2 July to more than 100 Friends. Aletia observed that Quakers in Australia are in a tough place. This is partly due to COVID-19. The frustration of not being able to meet in person has affected younger people in particular. The adoption of a variety of online and hybrid meetings has been a positive response, but meeting online is difficult for a number of people for various reasons.

The numbers of both members and attenders have continued to decline, and the fall-off in numbers of children and JYFs in recent years has been dramatic.

Nevertheless, there are signs of hope and growth. There are new attenders in many Meetings. Quakers have been actively involved in a wide range of peace and climate initiatives, and in sharing experiences of Spirit. The Quaker Peace and Legislation Committee and Quaker Service Australia continue their important work. Aletia sees the recently developed short videos for Australian Quaker Voices as honest portrayals of our values, spiritual life and action.

She highlights two issues of immediate importance: the climate emergency and inclusion of gender diverse people. Prompted by a "Share and Tell" session run by Rainbow Friends, she asks if it is time for Australian Quakers to state an intention to welcome gender diverse seekers, as Britain Yearly Meeting has recently done.

Aletia asks how we might become a truly "broken and tender" community which is thriving, nourishing, open and connected; tender to the Spirit and to each other; open to be led in unexpected directions. How best might we hold it with love and ensure that the seeds will grow?

We note Janet Duke (VRM) is willing to continue to represent AYM on this committee, but is unable to be present at meetings during 2022. We note that it has not been possible to find a suitable Friend to undertake this role in 2022.

AYM Nominations Committee notes that the following AYM positions remained unresolved at this time:

The terms of all three members of this committee will be finishing at YM22 and AYM Nominations Committee has been unsuccessful in finding Friends to replace them.

We would like Yearly Meeting to consider a possible different way of dealing with personal safety, and our legal obligations in regard to personal safety. Do the Safe Quaker Community and the Child Protection Committee deal with similar concerns? Does our inability to find members willing to take over the particular role of Safe Quaker Community present an opportunity to review and consolidate all aspects of personal safety?

This matter will be considered at a later formal session of this YM when other personal safety items come to a formal session.

AYM Nominations Committee brings to Yearly Meeting's attention that the following Committees have been laid down:

- a) Australia North Korea Peace Support Group
- b) Quaker Learning Australia Committee
 We note that WARM completed its term on Quaker Learning Australia at YM21, which
 was noted at that Yearly Meeting (Minute 21.35). SANTRM has agreed to do the on-theground hosting for Meeting for Learning for 2022 and 2023 (e.g. transportation to and
 from the retreat site). The actual Meeting for Learning program is being organised by
 the retreat leaders.

YM22.16: AYM Treasurer's Report update

AYM Treasurer's Report to Yearly Meeting 2022:

This is the first year that I am reporting as the Treasurer. Roger Sawkins, the past Treasurer, is a member of the Finance Committee and his continued presence is valued.

- 1. Annual General Meeting: The Annual General Meeting took place in January. The audited accounts for 2020/2021 were accepted at that meeting and the auditor reappointed.
- 2. Investments and cash flow: Financial markets settled during 2021, and there were increases in the values of assets held. The Sanctuary in Wahroonga was revalued at a higher value and our managed funds also increased in value. 2022 may be a very different year.
 - Our cash flow comes from the quotas paid by Regional Meetings which again were lower. The Federal Government COVID support has ceased so there will no longer be that offset. However, I expect for the next year or so, travel may be less as we get used to living in a hybrid online world. This will contribute to lower costs.
 - We also receive investment income and it was a lot higher than in past years. This was mainly because some of our managed investment funds sold assets and booked realised capital gains which was distributed as income.

Share markets have been volatile for the past few months. At this stage I am not sure how this will impact the annual performance for 2021/2022.

- 3. Bequests: During the year we received a large bequest of \$1 million and another of \$30,000. These are now invested and part of the Thanksgiving Fund.
- 4. Carbon offsets payment: Our carbon offset provision for the 2020/2021 financial year has been paid to Greenfleet.
- 5. The Finance Committee has circulated a draft Thanksgiving Fund Review Report to RMs and the Thanksgiving Fund for comments. A revised Report has been prepared. The AYM Thanksgiving Fund and the AYM Finance Committee are in the process of setting up a meeting to discuss the revised Review Report.
- 6. Finance Committee members: The Finance Committee membership has changed. The committee members are Jane Drexler (TRM), Treasurer; Ray Brindle (VRM); Roger Sawkins (QRM); Steve Smith and Robin Walpole (TRM).

We have no matters for consideration by Yearly Meeting.

Jane Drexler, AYM Treasurer, June 2022

Jane Drexler, AYM Treasurer, spoke to her report on AYM finances. We note that the report presented in this session is an updated report compared to that provided in *Documents in Advance 2022*. Budgeting for our 2022/23 financial year is progressing as normal.

She reported on the recent meeting between RM Treasurers and the AYM Treasurer. At this meeting there was discussion of implications of a possible increase in the number of paid positions to support the work of the AYM Office and other increases in AYM expenses. RM Treasurers expressed concern at the challenge of meeting increased RM quotas. Careful consideration will be needed of how funding of any increased expenses is met.

Yearly Meeting notes that there can be challenges in the timing of the AYM Financial Year and the associated needed AGM, and the timing of YM gatherings.

Yearly Meeting accepts the appointments of the four elective Directors to the Board of The Friends' School.

Yearly Meeting accepts the name of Rae Litting to serve on the Management Committee as a coconvenor while continuing as a member of the Linkages Committee, pending such time as another representative from NSWRM for the Linkages Committee is nominated.

YM22.19: AYM Handbook Revision Committee
