

PROPOSED REVISIONS TO THE RULES OF THE RELIGIOUS SOCIETY OF FRIENDS (QUAKERS) IN AUSTRALIA INCORPORATED

Under the Associations Incorporation Act 1991 (ACT)

The purpose of the proposed alterations is:

- a) To incorporate changes in government requirements – e.g. the existence of the Australian Charities and Not for Profit Commission; and a Common Seal is no longer required.
- b) To recognise changes in AYM’s structure – We now have a Coordinator, Communications Officer, etc.
- c) To make changes to and clarify our administration – allowing for online and hybrid meetings, changing the term “Yearly Meeting” to “General Meeting” to recognise that such meetings can occur more than once in a year.
- d) To change membership of AYM to include both Members and recorded Attenders of a Regional Meeting (collectively referred to as ‘Friends’). This is not intended to change any aspects of Regional Meetings’ treatment of Attenders – it is simply to recognise that Attenders will have automatic membership of AYM.
- e) To remove references to specific paragraphs of the Handbook and make other editorial changes for clarity, etc.

Recommendations for the Handbook Committee:

1. We suggest the Handbook define prerequisites for Officeholders, including the AYM Presiding Clerk, Treasurer, etc.
2. We suggest the Handbook Committee with the support of other Friends review the existing provisions for dispute resolution as to their applicability at AYM level.
3. We ask the Handbook Committee to review the Handbook in the light of the proposed changes to the Rules.
